Did you know that it is a criminal offence to knowingly contract a security service provider that does not comply with legislation?

SASA Gold Membership aims to positively impact the security industry by promoting the importance of compliance and the risk of non-compliance to not only the security industry role players, but to the **end users and consumers of security services** in South Africa.

By insisting that your security service provider becomes a SASA Gold member, you are forming part of the much needed self regulation that the Security Industry in South Africa desperately needs.

Gold Class Vision

The SASA Gold Class Membership ensures the end user of a security service that their security provider is compliant to legislation and protecting them against the PSIRA Act in terms of exercising due diligence and good corporate governance in ensuring that their supplier is compliant with legislation. Thereby, protecting themselves against prosecution in terms of the regulations made under the Private Security Industry Regulation Act 2001 (Act no. 56 of 2001 Section 38 (3)(g), (h)(iii).

In terms of Section 3(3)(g) of the PSIRA Act, persons who knowingly or without the exercise of reasonable care contract for the rendering of security services contrary to the Act, are guilty of a criminal offence. Any person found guilty of this offence is, in terms of section 38 (3)(h)(iii) liable to a fine or to imprisonment for a period not exceeding 24 months, or to both a fine and such imprisonment

"PSIRA Act:- (3) Any person who –

- (g) knowingly or without the exercise of reasonable care contracts for the rendering of security services contrary to a provision of this Act or the Levies Act; ..is guilty of an offence and –
- (h)(iii) on a conviction of a contravention referred to in paragraph (b), (c), (d), (e), (f), (g), (h), or (i), is liable to a fine or to imprisonment for a period not exceeding 24 months, or to both a fine and such imprisonment."
